<b>ORDER OF INCLUSION</b>	

THE COURT, having reviewed the Trinidad Ambulance District's Motion for Order of Inclusion, and having reviewed the official canvass results issued by the Las Animas County Clerk and Records Office, and being fully advised in the premises,

HEREBY ORDERS:

1. That the election on the question of inclusion of additional territory into the Trinidad Ambulance District (the "District") was conducted in accordance with the Uniform Election Code of 1992, as amended.
2. That a majority of the votes cast at the election were in favor of inclusion.
3. That, in accordance with C.R.S. §32-1-401(2)(e), the area described below shall be considered included into, and shall become a part of the District:

All taxable real and personal property located in Las Animas County, Colorado, excluding any and all taxable real and personal property currently located within the existing taxing district boundaries of the Trinidad Ambulance District and further excluding any taxable real and personal property located within the existing taxing district boundaries of the Kim School District, as determined by reference to the current records of the Las Animas County Assessor's Office.

4. That, in accordance with C.R.S. §32-1-401(2)(e), the validity of the inclusion may not be questioned directly or indirectly in any suit, action, or proceeding except as provided in article 11 of the Uniform Election Code of 1992, as amended.

5. That, in accordance with C.R.S. § 32-1-105, a copy of this Order be recorded in the real property records of the Las Animas County Clerk and Recorder's Office.

6. That, in accordance with C.R.S. § 32-1-105, a certified copy of this Order be filed with the Assessor of Las Animas County, Colorado and the Division of Local Government in the Department of Local Affairs.
