Auditor Report	Telephone conference with Mike Rowe, partner of Stockman Kast Ryan & CO LLP, was initiated to review the completed 2014 audit. Mike states that the first year is always the most difficult on the staff. However, he greatly appreciates the staff involved on the TAD side for their time and effort. There was a review and discussion about the significant audit findings, the deficiencies and weaknesses found during the audit, the financial statements, the supplemental information and the independent auditor's report.
	Overall, everything looks really good. There are no monies missing and the District is in a good financial place. Mike does request though that all parties

involved in the audit begin communications for the 2015 audit in November/December of 2015. This will help the 2015 audit run more smoothly.

There were no further questions or concerns. Telephone conference ended.

Financial & Billing Report Nothing in particular stands out. Everything looks good. Bernadette was able to get the April credit card statements reconciled and categorized, which should be reflected on the May financials.

Billing procedures are running smoothly and there are no issues of concern.

Director's Report

The Supreme Court finally made a positive ruling regarding whether employers can fire employees for marijuana use. Any employee or volunteer found to be using marijuana, even for medical reasons, while on duty can be fired by the District.

We applied for three grants and just heard that all three were approved. One grant will be for a new ambulance. Dan Bates passed around the new design for the ambulance. The second will be for Stryker Stair Chairs. The third will be for AED's that we can place both within the District and around the county.

Dan Bates gave an update on the electrical/mechanical issues that we have had with 3103. A brief discussion took place and the Board would like to make a plan. Whether repair or replace, they want to get the ball rolling with 3103. Dan Bates will prepare options for 3103 that can be voted on at the July board meeting.

Our 911 calls have gone down in the last month. However, our overall calls are up significantly from last year. We had 49 transfers in the month of May, which is a new record for the District.

Eric Winter has resigned as a Paramedic to pursue furthering his education. His going away party will be Friday the 26th at the Triggers game and all Board members are invited. The District is starting the interview process to replace him but has enough coverage until the right candidate is found.

Dr. Weber says that after a couple of years of working with our crews, they are finally starting to understand what he is looking for in their documentation. Charts are looking good and he is sending fewer back each time.
