Financial & Billing Report	Everything looks good. Supplemental report will be provided in the future. \$7,500 to county from RETAC Grant will be disbursed prior to next meeting. Expecting receipt of \$87,018.60 grant funds from CDPHE for new ambulance
	All accounts are reviewed monthly by Bernadette Cappellucci who has been attending monthly meetings. Billing procedures are running smoothly: there

are no issues of concern. In the future, Bernadette will only attend quarterly or upon request.

Brief discussion regarding Medicare and Medicaid percentages on the Payor Charts and the billing/payment process. Medicaid clients have increased over Medicare. Medicare being a very good payor. There are very few bad debt write-offs.

Director's Report

The Board reviewed the News 5 broadcast regarding the Trinidad Ambulance District's new AEDs, ERT team members and new ambulance. The Board will view the new ambulance after the meeting. Five thousand EMS personnel from 50 states and 48 countries were in attendance at the Las Vegas Show. The new ambulance was a big hit. Organizers said they had never had so much traffic through an ambulance in the history of the show. EMS One an online site and EMS World magazine are doing stories on TAD.

Several properties were discussed for the new location of TAD. Scott Sandlin came back with an offer of \$2.1 million on the Trinidad Builders property. Discussions were held with LeeAnn Fabec about the possibility of utilizing the back of the Justice Center at no cost. She will discuss the issue with the County Commissioners. There are concerns about the sewer system in this building. A parcel of 5.5 acres near the Holiday Inn is also being considered for the new TAD facility. Another option mentioned property on Moore's Canyon Road but interstate accessibility was a concern. Gloria Coch property at exit 15 and Frontier Motel properties were discussed but both have drainage issues. Access issues were discussed regarding Industrial Park properties.

We are currently fully staffed.

Intermediate class currently in session and EMS training concluded. The Fire Department has recently received training.

No further questions or discussion took place.
