Call to Order/Pledge

Meeting was called to order at 4:30pm by Kathy Bueno.

Roll Call/Proof of Quorum

There was a quorum with all five board members in attendance.

**Proof of Notice**

Approval of Minutes

Financial / Billing Report

Bernadette Cappellucci of Century Financial Group submitted monthly financial reports for the month ending April 30, 2020 along with the following written statement, "the financials for Trinidad Ambulance District appear consistent with the normal month to month income and expenditures."

Dan noted Balance Sheet, Line Item 105.2, Property Tax Receivable at \$1,006,442.00 should, in his opinion, be listed under Accounts Receivable as it denotes \$985,292 collected to date in property tax plus \$21,130 for specific ownership taxes.

Trinidad Ambulance District received \$31k as a CMS COVID payment. Additionally, the district does not bill out Medicare from January through February in anticipation of deductibles having been met thus creating a higher level of income in April. These two occurences make First National Bank account #49824 reflect a \$100k above average balance.

The Balance Sheet Previous Year Comparison reflects a decrease in account balances for 2020 due to the fact that the district paid for a new ambulance. Property and specific ownership taxes continue to decline which is reflected on the Profit & Loss Previous Year Comparison, Total Income for 2020 is down \$103k.

**Motion** to approve the April 2020 financial report as presented was made by Joseph Martinez and seconded by Nick Mattorano. The motion passed unanimously.

Director's Report

**2020 Ambulance Update.** The newest member of the fleet is due to be picked up June 18, 2020.

**Grant.** Sometime in June, the district will receive word on the grant application to purchase a UTV, an additional Lucas Device and two additional extrication tools.

<u>Fishers Peak Park.</u> After participating in a tour of Colorado's newest state park, it is clear that a UTV will be most beneficial. There is very little vehicle traffic within the park.

Huerfano/Las Animas County Tactical Medics. The Sheriffs of Huerfano and Las Animas Counties have agreed and are asking Trinidad Ambulance District to enter into an inter-governmental agreement to provide Tactical Medics, among other services, to each other when needed. The board was provided a copy of the agreement

> for review. The medics would be standing by or "staging" in cold zones in the event of an emergency. Dan is seeking board approval to proceed.

> Kathy Bueno stated the necessity for small communities to collaborate whenever possible. In her opinion, it is nothing but good for everyone involved.

Clay Hart asked to be provided a copy of the Possee policy. Dan explained that he and a handful of other medics are already part of the Las Animas County Possee and act with very limited power under the direct supervision of the Sheriff. Clay was also curious about liability. Nick Mattorano explained that when acting in the capacity of the Sheriff's Office the liability falls on the Sheriff's Office.

Although no vote was taken, it is the consensus of the board that TAD entering into an inter-governmental with the Huerfano and Las Animas County Sheriff Departments would greatly benefit those in both communities. Thus, consent was provided to Dan Moynihan to enter into the inter-governmental agreement.

#### Operations Report

Gabe Moreno told the board that overall call volume is down since the COVID-19 outbreak. He presented the following statistics for the month of April 2020:
