2017 Certification of Mill Levies and Revenue

TO: Trinidad Ambulance

The budget process determines what revenue is required to operate each entity for the upcoming year. Each tax entity determines the revenue needed from property taxes to operate the entity. It is Las Animas County's responsibility to check the calculations to insure the amounts are accurate. Please see the example below to calculate the correct mill levy and revenue.

EXAMPLE:

Assessed Valuation - 100,000,000.

Mill Levy = 1.3980% or 13.98 Mills (please use total number of mills when you certify the levy)


Revenue = \$1,398,000. (100,000,000x13.98/1000) or 100,000,000x1.3980%
