Item 6 on the August 25, 2021 agenda entitled Administrative Vehicle Replacement required a vote.

We would like to replace Captain DeTray's vehicle which currently has 93,000 miles on it. The Town of Aguilar has expressed interest in that vehicle for their Emergency Manager.

The replacement vehicle is a 2020 Ford F150 with 30,000 miles on it. It already has emergency lighting and was a demonstration unit used by MHQ in Albuquerque. They are selling this vehicle for \$42,500. Just as we have a replacement schedule for our ambulances, we need to have one for our administrative vehicles as well.

Director Nick Mattorano has personally inspected this vehicle and recommended to Sheriff Navarette that he purchase it which he declined. Nick's opinion is that this vehicle is priced thousands below what it would cost to build an emergency vehicle. Also, with the current shortage of vehicles coming from Ford, it could take up to a year to find another replacement vehicle.

Approval would allow the purchase of this 2020 Ford F150 with 30,000 miles on it for \$42,500.
