Financial Report

Bernadette Cappellucci of Century Financial Group prepared the February 2022 financial report with the following statement: "The financials appear in line with the normal month to month income and expenditures. I see nothing out of the ordinary to report or anything concerning in any of the financial reporting for the month ending

February 28, 2022."

Dan Moynihan pointed out the following information:

- Cash On Hand \$2,506,810
- Accounts Receivable was at \$800,000 three months ago
  - o Currently at \$355,855
  - Quick Med Claims has been working older claims and Sandra Brady is back as our account manager.
  - O Collections are up \$72,000 this month and billing fees are up to \$12,000 (6.5% of collected fees).
- Net Income comparison January is typically the lowest month for cash on hand due to property tax being due in April. The revenue will start showing on the May financial statement.
  - o January 2021 was down \$32,012
  - o January 2022 is down \$15,572
- Property Taxes are down. Tax Levy increase will be necessary.
  - o 2021 Projected \$985,292: Received \$877,000
  - o 2022 Projected \$954,927
- WARNING! Medical supplies are becoming difficult to acquire. Prices are increasing along with fuel (+\$2.00/gal compared to this time 2021). Increased transport distances are common.

Valerie Borsa asked if there was a plan for the medical supply issue. A stock of some supplies is sufficient and other options were described.

EMS/MC Billing Contract

At the February meeting the board requested reference checks for EMS/MC. Barbara Fisk reported responses from two out of three (third nonresponsive) as being extremely favorable e.g. communicative, timely, accounts receivables. It was clarified that EMS/MC interfaces with ESO and Image Trend. The EMS/MC contract had been previously provided to the board for review.

Medical Director Contract

Dan introduced Dr. Jeremy DeWall who is interested in becoming the new Medical Director for TAD. Dr. DeWall has a long history of experience in the EMS world e.g. EMTB, Paramedic, Flight for Life, E.R. doctor. He worked as a Paramedic through medical school and has maintained his certification. He is currently an E.R. doctor in Woodland Park, volunteers on the Custer Search and Rescue team and Teller County.

Dr. DeWall has stated he will accept RETAC grant funds in the amount of \$15,000 as payment for his medical direction for TAD and he will include Kim. TAD Attorney Les Downs has reviewed the medical director contract and has asked that it be simplified, if possible.

Election Judge Fees Director's Report

Barbara Fisk informed the Board, in previous years, election judges were paid a flat fee of \$200 per day. Most Special Districts pay the judges directly instead of payment coming from the Designated Election Official. The reasons are simplicity and timeliness of the transaction. Their day will begin around 6am and not end until all documentation required of them is processed after the polls close. This could take up to four additional hours. It was noted that most judges do not realize they are paid for their service. Typically they are doing it as a community service. The State of Colorado Secretary of State has a program in place where student's meeting the necessary requirements may service as judges. Barbara would like each polling location (Primero Community Center, Aguilar Community Center and 939 Robinson Ave., Trinidad) to be staffed by one adult and one student judge. Barbara asked the Board what they would like to do for the upcoming election.

Fleet Report

Captain DeTray reported that supply issues are not only affecting medical supplies but also vehicle parts. One ambulance is currently out of service awaiting a part from Alabama. Service times are taking longer. 1701 had injector gasket, valve cover gasket and steering box issues. 1501 has new tires. An ambulance experienced a critical failure while responding to a call at Fishers Peak State Park. The second rig was on the way back from Colorado Springs so they took the call. Gabe Moreno has submitted a grant extension request for the rechassis of 1901. Materials are not expected to be available to Excellance until approximately June 23, 2022. When the grant application was submitted is was expected the rig would have approximately 150,000 miles on it. It currently has 175,000 miles.
