SUBJECT DISCUSSION

Call to Order/Pledge Meeting was called to order at 4:32pm by Nicholas Mattorano.

Roll Call/Proof of Quorum There was a quorum with five (5) board members in attendance.

Financial Report Bernadette Cappellucci of Century Financial Group prepared the

May 2022 financial report with the following statement: "The financials appear in line with the normal month to month income and expenditures. I see nothing out of the ordinary to report or anything concerning in any of the financial reporting for the month ending

May 31, 2022."

Trinidad Ambulance District Regular Board Meeting June 22, 2022

Chief Gabriel Moreno pointed out the following information:

- Cash On Hand \$2,766,086
- Overall expenses are down \$65,687 from this time last year.
- Medical supplies continue to increase in cost and shortages continue. Costs are up 40% from this time last year.
- Vehicle maintenance (availability of parts) and fuel costs continue to be issues. Fuel is up \$13,004.91 or 82% from this time last year. Mid-grade is currently \$5.16 up nearly \$2.00 in one month.
 - (Reported May 25, 2022: mid-grade \$4.74 and diesel \$5.54 as of Monday, May 23, 2022).
- Information was received from Las Animas County Assessor Jodi Amato that OGRIS does owe back taxes from 2020 and 2021 but are making small payments to amend. Also TAD is receiving minimal taxes from the wind farm (10 in Las Animas County) north of Trinidad.

Clay Hart voiced concern about Cash On Hand dropping from last year. He was reminded the District purchased the property and building at 13840 Hwy 350 and one ambulance without grant funds. It was also explained, when looking at the monthly Balance Sheet, in order to figure the actual Cash On Hand, the County Treasurer Cash (line item 105.1) and Property Tax Receivable (line item 105.2) must be deducted from the Total Checking/Savings dollar amount. These two line items are projected for the year not actual Cash on Hand.

Director's Report

Medical Director. Medical Director, Dr. Jeremy DeWall, will be here June 23, 2022 to conduct Airway Management Training.

EMS/MC Billing Company. The new billing company provides weekly reports and follow-up. Dan Moynihan is still waiting on a reply from Quick Med Claims regarding the outstanding accounts receivable due to their lack of filing in a timely manner.

USDA Loan. The loan application packet was forwarded to the national office on June 13, 2022 for approval.

Public Relations. Members of TAD participated at the following events: Stonewall Auxiliary Fishing Tournament and Spanish Peaks Volunteer Fire Department Breakfast Fundraiser. TAD is partnering with Nikki Shannon of Kim EMS to facilitate and EMR class in Branson. Employees volunteered to host a booth at Santa Fe Trail Days. Goodie bags were handed out to children along with free raffle tickets to win summer fun toys. SIMMAN, CPR Annie and Baby Annie, LUCAS, ambulance and UTV were on site providing community education opportunities.

Education. We currently have four paramedic students, two from Trinidad State Junior College and two from Pueblo Community College, doing their program required ride-alongs with us. ACLS/PALs continuing education class was offered at TAD.

Grant Updates. Administrators met with the Las Animas Board of County Commissioners on June 7, 2022 to discuss RETAC grant process. Since we are still unable to obtain a chassis within the state timeline, an extension for the CDPHE grant to remount VIN7420 (inter-facility rig) was submitted and awaiting guidance.

Training, Search and Rescue, Tactical Medics and Emergency Preparedness. Extrication training was conducted on May 31, 2022. In order to prepare for an emergency extrication, a walk-through with the US Army Corps of Engineers, Trinidad and Fishers Peak Fire Departments and TAD at the Dam Tower. Additional scenario training will take place involving all departments. TAD personnel participated in two Search and Rescue events in June. Both were successful. Chief Moreno and Deputy Chief DeTray were asked to participate as mutual aid tactical medics in Walsenburg with Pueblo Police Department SWAT.

Insurance: Open enrollment for medical insurance is September 1, 2022. At the next board meeting, the board will be asked to review and provide opinions on optional plans for employees. The current plan will only be increasing by 1.84%.

There is a new Family and Medical Leave Insurance (FAMLI) program for which TAD must "opt out" of or automatically be enrolled. The plan has premiums based on salary (0.45% from employee plus 0.45% from employer) totaling 0.90%.

Vehicle maintenance is ongoing. Two recalls have been presented; one completed, the other will not have parts until the third quarter of 2022.

Deputy Chief DeTray shared a personal story about ambulance staffing and response times in LaVeta. Their operation is down two paramedics and one truck.

Miscellaneous

Clay Hart wanted his concern with administrators taking company vehicles home on the record. Increased fuel costs and maintenance expenses need to be watched.

Floyd Duran asked how TAD pay compares to the national average. National average wage, per salary.com, for a Paramedic is between \$41k-\$52k; for an EMT between \$34k-\$42k. TAD average salaries, based on 2021 w2s, for Paramedics was \$67,031 and EMTs \$47,520.
