**A Resolution of the Board of County Commissioners of
Las Animas County, Colorado renewing the Trinidad Ambulance District (TAD)
Ambulance Service License thereby allowing TAD to provide ambulance service
and support within Las Animas County during the calendar year 2022**

Resolution # 22-013

Whereas, The Colorado Department of Public Health & Environment, the Health Facilities & Emergency Medical Services Division and the State Board of Health has enacted rules pertaining to the administration of emergency services operations within each respective county within Colorado; **and**

Whereas, In July 2006, the Las Animas County Board of County Commissioners adopted rules and regulations establishing minimum standards for the provision of ambulance services within Las Animas County in conformance with said State agency rules and regulations; **and**

Whereas, An ambulance service license was initially issued to the Trinidad Ambulance District in December 2006, and has been renewed annually through 2021, authorizing it to operate an ambulance service in Las Animas County, in compliance with the Las Animas County Ambulance Service Regulations and Licensing Procedures Manual; **and**

Whereas, The Trinidad Ambulance District has filed an application requesting renewal of its 2021 license seeking authorization to provide ambulance service within Las Animas County for calendar year 2022.

**Now, therefore be it Resolved by the Board of County Commissioners of
Las Animas County, Colorado, that:**


1. The Board hereby authorizes the renewal of the ambulance service license issued to the Trinidad Ambulance District for the provision of ambulance services within Las Animas County for the calendar year 2022, in conformance with the rules & regulations adopted by Las Animas County, Colorado.

Upon motion made and seconded and an affirmative vote, this Resolution was adopted this 1st day of February 2022.


