Financial Statement	Bernadette Cappellucci of Century Financial Group prepared the financial report for April 2024 with the following statement: "The financials appear in line with the normal month to month income and expenditures. I see nothing out of the ordinary to report or anything concerning in any of the financial reporting for the month ending April 30, 2024."

- Concerns
 - 1. Colorado passed legislation, with only 3 days left in session, to reduce property tax and exempt primary residence valuation from taxation. The bill was around 300 pages and nobody really understood it, including our lobbyist. It supposedly protects special districts from a reduction in funds by "backfilling" income loss, similar to this year, but nobody truly knows what that means or looks like.
 - a. In November 2023, the Governor introduced a tax break that caused Assessed Values to decrease with the promise of a "backfill" to Special Districts in March 2024. TAD had to reduce its budget by \$54,000 to accommodate the loss of income. The "backfills", from TABOR funds in the amounts of \$55,655 (SB22-238) and \$53,794 (SB23B-001), totaling \$109,459 were received by TAD in March 2024.

The building interior should be buttoned up by the end of month with focus on concrete and asphalt. Appliances were ordered today because of Memorial Day sales \$5,000 was saved. There is a backup generator on site. We're hoping for a July move in.

1501 Remount Update. 1501 was picked up In Madison, AL on May 14th with no issues. It will be numbered as 2302 and is going to Denver Friday for decals. It is expected to be in-service by the end of June.
