Roof Repair Estimate

Chief Moreno present two estimates from Commercial Roofing Restoration to repair leaks to the roof at 13840 Hwy 350. These leaks were not covered by Veltri Contracting's contract with the District as the leaks are considered pre-existing not part of new construction.

Estimate #11204 encompasses the entire roof, pre-existing and new construction in the amount of \$73,800.00; Estimate #11205 encompasses only the pre-existing roof in the amount of \$49,800.00 and both estimates note a 55% deposit with 45% due upon completion.

Body Cameras. The District had a second employee assaulted, resulting in injuries and a workers' compensation claim. The perpetrator has been charged with 2nd degree assault. Chief Moreno, already having received authority from the Board to use body cameras, is asking the Board to approve a five (5) year contract with ProVision in the amount of \$18,000. Thus saving the District \$3,600.

EMS/MC. Year to Date Net Collections \$1,041,048 plus \$10,289 on old accounts receivable.

MSRH/TAHA Appeal. Oral arguments were September 10th at 1:30pm. It may take weeks or months for a verdict.

CIHCS / **Health Service District.** Deputy Chief DeTray received his State Community Paramedic endorsement. The State will be calling with some final questions before submitting their recommendations to health facilities for licensure.

Miscellaneous

Tom Murphy to provide video of 2008 sales tax vs property tax debates. Joe, in his role of Las Animas County Emergency Manager is in the process of establishing service with First Net countywide. He also reported that RAVE provides reverse 9-1-1 calls. It has a program where it will "reach out and grab" phone numbers without people having to signing up. The fee is \$4,300 per year. They County may provide \$1,000 toward the fee. Joe also reported that the TAD budget preparation meeting was very successful and a good group effort. Chief Moreno explained the reason for tomorrow's Special Meeting is due to Spencer-Fane informing the District needs a Resolution to sell property and assign a signer. Les Downs, although not present, provided each board member with a memorandum stating with reasoning, "when you receive a group email from myself of permanent staff, or anyone of you that goes to the group, please don't ever hit "replay all" in your response."
