SALE/DONATION OF FLEET VEHICLE. The Board discussed options of selling or donating the 2009 International Ambulance VIN 1HTMNAAM19H145589 the is currently part of the fleet. Deputy Chief DeTray forwarded information he received about ambulance donations to Kenya. It was decided that the ambulance is too much of an investment to not offer locally as a donation but, if no one is interested, could be sold. This item was tabled until the March meeting to allow time to research the ambulance value.

ZOLL EXTENDED WARRANTY. Chief Moreno presented the Board with a 3 year extended warranty agreement from ZOLL for the new ventilators (3). Service includes annual service and one battery per device per year. Each ventilator cost \$30,000. The total contract price for service from 1/1/2025-12/31/2027 is \$13,851 or approximately \$1,500 per device per year. Chief Moreno would like to pay in full so has brought to the board for approval.

MOTION to purchase and pay-in-full a 3 year service agreement for the new ventilators from ZOLL was made by Joe Richards.

Director's Report

Chief Moreno informed the Board that the 2025 EMS Guidelines have been released and currently in use.

939 Robinson Ave. The property is currently being advertised for sale or lease at \$5,000 per month. No developments to report.

Grants. The AFG grant is still pending. The EMTS grant was submitted for a PICCOLO device and two oxygen concentrators.

Updates.

• Jan 23 – Met with the Trinidad Police Department co-responder who will be able to conduct mental health assessments, including toxicology labs, and decide placement options. There is a holding facility in Pueblo which doesn't require placement approval. With the Health Service Plan, TAD can transport via secure vehicle (no

- ambulance) and by pass the local hospital.
- Every Friday Attend State EMS Advocacy Committee meeting.
- Feb 7 Met with National EMS Attorney.
- Feb 11 Attended Colorado Whole Blood Coalition meeting. There are currently 4 fire departments in the state operating a pilot program. Rural Colorado's main concern is alleviating waste.
- Feb 12 Participated in the EMS Sustainability Task Force. Our Risk Assessment form has been requested. The State may set stricter standards.
- Feb 13 Engaged in the Inter-Facility Transport Task Force.
- Feb 17 Attended CIHCS Advocacy meeting, HB25-1008 Advocacy Meeting (balance billing) and Health and Human Services Committee.
- Feb 18 Attended EMS Day at the Capitol, met with state legislators in support of EMS bills.
- Feb 20 Attended Colorado Senate Health and Human Services Committee (CIHCS Sunset) hearing.
- Feb 21-23 Hosted annual BLS Refresher
- Feb 24 Participated in the Colorado Prehospital Addiction Care Consortium (CPACC). The state will be providing Narcan Kits (50 to start) and training to fulfill community requests. Distribution numbers will be provided to the state.
